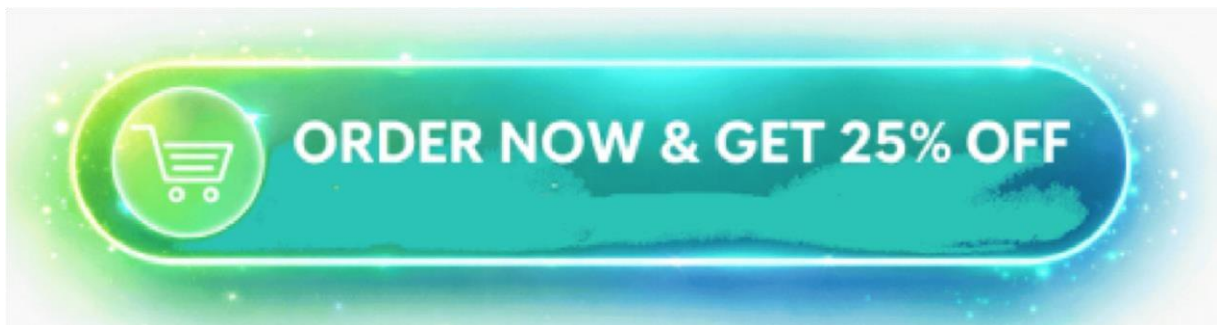

Oxycodone works by binding to mu-opioid receptors in the brain and spinal cord, reducing pain perception—but it also carries significant risks of respiratory depression, addiction, and withdrawal.

For opioid-naïve patients, OxyContin® 60 mg and 80 mg tablets are contraindicated due to fatal overdose risk.

Total daily dose should rarely exceed 80 mg unless the patient is heavily opioid-tolerant under specialist supervision.

Common Side Effects and Serious Risks

Common (Usually Mild to Moderate) •

Nausea, vomiting, constipation

- Drowsiness, dizziness
- Dry mouth, sweating

Serious (Require Immediate Medical Attention)

- Slow or stopped breathing (respiratory depression)

Some states still require at least one in-person visit before prescribing opioids due to DEA and state board rules.
